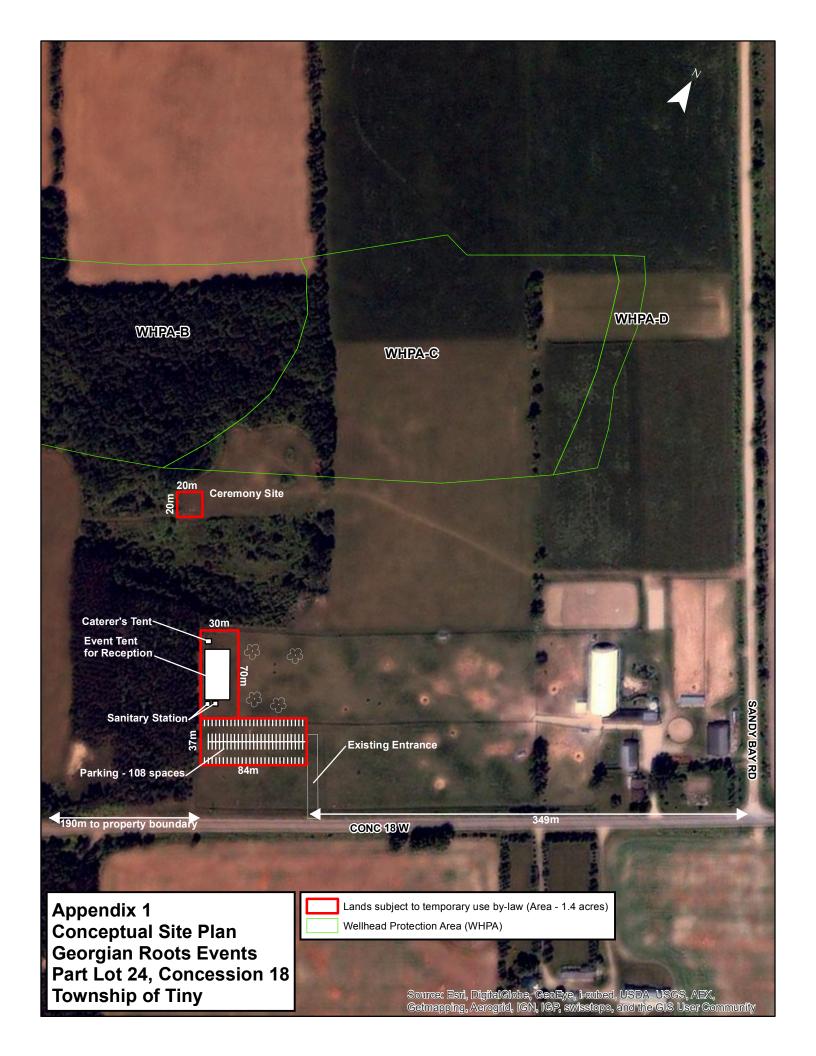


Township of Melancthon Feral Cat Rescue Proposed Site Plan Part of Lot 5, Concession 3

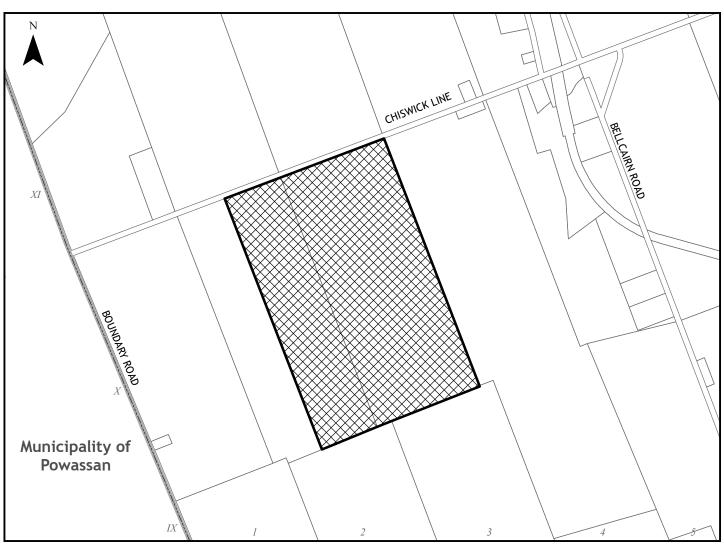
